DEADLINE FOR ENTRY: Sunday, November 16, 2025, 11PM (Pacific Daylight Time)

Notification of acceptance or exclusion from the exhibition will be sent via email by the first week of December, 2025.

Deliver work: Sunday January 18, 2026 5-7PM or Monday, January 19, 10AM-2PM

Pickup unsold work: Sunday March 1(10AM-2PM) or Monday March 2(10AM-2PM)

Eligibility:	All artists currently living in Northern California
Media:	All media except video, crafts or installation
Size:	Not to exceed 5' (60") in any direction
Entry Fee:	\$20 per artwork entry, up to a maximum of 4 total entries

APPLICATION: Online only, through callforentry.org

JURYING PROCESS: Jurying will be done from digital images submitted through callforentry.org

AWARDS: Juror will select up to seven artworks for cash awards and art supply gift certificates.

ACCEPTED WORK: Artwork must be clean, framed, wired and ready to hang or place on a base. Paint and any other materials must be dry. Each artwork must be clearly labeled on the back or bottom of the piece with the following information:

INSURANCE: GRO does not offer insurance to cover your artwork while it is in the gallery or in transit to or from the gallery. If you require insurance for your piece you should pursue this on your own.

DELIVER WORK: Sunday January 18, 5-7PM or Monday January 19, 10AM-2PM

Work that cannot be hand delivered must be shipped at the artist's expense both to Gallery Route One and from GRO if the work is not sold. Artist must ship work in a returnable carton. Work that is not prepaid for return or not shipped in a two-way carton will not be accepted.

SALES: Gallery Route One's commission is 45%. Work will be for sale at the price indicated by the artist upon submission of entry, plus tax. Sale of artwork is subject to GRO's commission until the end of the exhibit.

ABOUT THE JUROR: Lori Austin is a Northern California gallerist, curator and founder of Lori Austin Gallery in Sonoma and Healdsburg. With over 30 years experience in the art world, she is known for her curatorial focus on contemporary and indigenous art. Her galleries highlights work that bridges cultural traditions with contemporary expression. As a juror, Austin brings deep commitment to artistic integrity and diverse perspectives.

ABOUT GALLERY ROUTE ONE: Gallery Route One is a 501c3 nonprofit organization. GRO's Mission: To originate and present contemporary art exhibitions, educational programs and community outreach to inspire people to experience the world in new ways. The artists at GRO believe that art can be a powerful force for change, and that artists have much to contribute to the dialogue about critical problems we face as a society.

GRO was founded by 25 artists in 1983, and currently maintains a membership of 15 plus artists. Artists are selected via a jury process. The organization supports two exhibition programs: GRO artist exhibitions in the Center and Annex Galleries and Visiting Artist exhibitions in the Project Space. GRO's Board of Directors is drawn from interested community members, including artists. GRO supports two community outreach programs: Artists in the Schools and the Latino Photography Project.
